### \*Canoe Kayak Canada Fees

**Paddlers are required to pay CKC fees at registration.** These fees must be paid whether or not paddlers compete. 100% of this fee is returned to Canoe Kayak Canada, the governing body, to assist in the promotion and development of the sport on a Provincial, National and International level. Exceptions: Kiddie Kanoe and recreational masters

\*\*The CKC fees are separate from the Club fees and cannot be included in family packages.

**Club Fee Notes:** Additional family members only apply to immediate family members. Additional members are always the participants in the lower cost category. Kiddie Kanoe classes are 1 hour long, 3 times/week for a 2 week session. Atoms and all other youth age groups practice every day Monday to Friday with the opportunity to participate in weekend Regattas a few times through the summer season. The club fee covers the cost of running the paddling program including coaching, equipment, and other administrative costs.
